






















Board Chairman's Message

We celebrated our 62nd anniversary in 2024 and HRCU continues to grow in loans, deposits and services to members. As a well-capitalized credit union, members can feel assured their funds are safe and secure at HRCU.

A major accomplishment for 2024 was the opening of our newest branch in Greenland, NH. The community has been very welcoming and increased memberships, deposits and loans have shown to be very promising. We ended 2024 with 24,830 members and \$443M dollars in assets. Despite higher interest rates, loan volume continues to grow but at a slower rate from previous years. Our team worked hard to ensure loan rates were competitive and in most cases below peer averages across the board. HRCU remains and always will be a responsible lender which is indicative of lower delinquency rates in an unsettled economic year.

In addition to a strong lending program, higher savings rates are being paid to members. When combined, it is impressive to think about the formation of Holy Rosary Credit Union in 1962 with a handful of members and a few dollars establishing an organization with the credit union philosophy of people helping people. We have seen a significant increase in online and mobile banking transactions and have state of the art programs to enable nearly all banking activities to be done wherever you need to 24/7. Many of our members still prefer the in-person banking experience at one of our now five local community branches and we still welcome them to do so.

Our management team and staff continued to do an outstanding job serving our members in 2024. The dedication of our member services team, loan team and support staff does not go unnoticed or unrecognized by management and the Board. They are all to be commended for going above and beyond to serve our members every day with a great attitude and professionalism.

Along with the management and staff, we would like to thank our dedicated members for your continued patience, understanding and support. The loyalty of our members remains very strong.

It gives me great pleasure to recognize the commitment and dedication of the management and staff at the credit union and assure you their commitment to our credit union, its purpose and their working relationship with the Board is second to none. I would like to personally thank the members of the Board of Directors, Supervisory Committee, and Council of Trustees for their service to HRCU. The volunteers serve because of their belief in the credit union philosophy and their desire to make HRCU the best financial institution available to its members.

I look forward to watching HRCU grow as your neighborhood credit union, well into the future.

As we welcome 2025, I want to take a moment to express my deepest gratitude to each of our members for your continued trust and partnership with HRCU. Your loyalty and engagement remain the foundation of our success, and it is an honor to serve as your President and CEO. I am proud to share some of our key accomplishments from 2024.

This past summer, we were excited to roll out our new look. It was a significant undertaking, and we wanted to ensure that both staff and members had a voice in the process. Our previous logo had evolved over the years, and we took this opportunity to also evaluate our mission and value statements. As we continue to grow, it is essential that we remain relevant in today's market while staying true to our core values and commitment to our members.

After exploring many iterations of trees, leaves, and other design elements, we arrived at a brandmark, logo, and tagline that best represent who we are and where we are headed as an organization. We look forward to continuing to be "Your Neighborhood Credit Union" for many years to come.

In November, we opened our new branch in Greenland. After careful consideration of expansion into a new market, we found Greenland to be an ideal location—centrally positioned and in a town that had been without a financial institution for the past 20 years. We were excited about the opportunity to bring HRCU to this growing region of New Hampshire. Additionally, we partnered with the Pink Hippo Café to offer a community lounge for our new neighbors. In just a few months, we have already felt a warm welcome from Greenland and the surrounding community.

Financially, 2024 was one of HRCU's strongest years to date. In a year of higher interest rates, through prudent management and a focus on efficiency, we were largely able to keep our loan rates below market averages. HRCU originated over \$82 million in new loans directly for members of our community. Beyond providing affordable loans, we recognize that uncertain economic times can bring unexpected hardships. Our team remains dedicated to working with our members, offering compassionate support and reinforcing our commitment to helping our neighbors.

Our commitment to the community also grew in 2024. Our Christmas Caring Campaign celebrated its 11th year, surpassing a total of \$340,000 in donations. We continue to support education by increasing the number of college scholarships to 15 for 2025. This past year, we exceeded \$122,000 in community donations and contributed countless volunteer hours to local initiatives.

Finally, to our dedicated team at HRCU—including the Board of Directors, Supervisory Committee, volunteers, management and staff—thank you for your unwavering commitment to serving our members with excellence and care. I never take for granted the opportunity to lead an organization that prioritizes doing what is right for its members.

And to you, our members—thank you for being part of the HRCU family. Your trust in us inspires everything we do.

Supervisory Committee Report Robert Langelier | Chairman, Supervisory Committee

The responsibility of the Supervisory Committee is to ensure the credit union is soundly managed and its financial interests are protected. Our team consists of five members and nine meetings were held during the year.

- An external audit of HRCU's financial records was conducted by an independent auditor to ensure the accuracy and compliance with accounting standards.
- Multiple internal audits, consisting of an examination of HRCU's procedures and operations, were conducted by an independent auditor to ensure HRCU's internal controls were effective.

Our meetings focused on a variety of topics:

- financial reports by management,
- a review of Visa expenditures,
- a review of security controls instituted by our IT Department,
- an approval of Quarterly Branch audits, financial reconcilements, and travel and conference expenditures by management,
- a review of new and closed accounts,
- a review of monthly board minutes,
- a review of Allowance for Loan and Leases Audit, and
- a report on HRCU's compliance with the provisions of the Automated Clearing House.

We kept abreast of management's compliance with all recommendations by the auditors. In conclusion, HRCU is guided by a strong management team and a dedicated group of volunteers.





In Remembrance

The Founders of Holy Rosary Credit Union

In 1962, Rochester, New Hampshire was a place filled with a rich heritage, shift workers, small entrepreneurs, and recent immigrants, most of whom did not speak English very well. In the beginning of the 20th century, church-sponsored credit unions began to spread throughout New England.

This idea soon spread to Rochester, and a group of Holy Rosary parishioners met to lay down the foundation for what would soon be Holy Rosary Credit Union:

Robert Chasse Arthur Gagnon Gerard Gravel Rodolphe Hamann Lucien Paradis John Paul Roy Angie St. Pierre Monsignor Gilles Simard

From grocery store and shop owners to accountants and builders, the founders of Holy Rosary Credit Union were all hard-working small entrepreneurs with one objective in mind "to show love through the instrument of lending." They shared a belief that everyone deserves access to financial opportunity.

With an initial deposit of \$600 and 63 years later, their legacy lives on as HRCU continues to grow. Today, the credit union stands with over 24,000 members, 5 branch locations, and \$443 million in assets. We are deeply grateful to our founders for their vision, dedication, and commitment to building a financial institution that puts people first. Their values continue to guide us today towards a stronger and brighter future for our community and members.

We dedicate this year's Annual Report to Robert Chasse who passed away in 2024. Bob was the last remaining founder and in 2023 was recognized for his years of service at our annual meeting. Bob served as HRCU's third treasurer in the mid-1960's and conducted transactions at his place of business, Chasse's Market on Washington Street. He then served many years on the Board of Directors and most recently on the Council of Trustees. Bob will be missed but like all of our founders, his memory and contributions will live on.
