We celebrated our 61st anniversary in 2023 and HRCU continues to grow in loans, deposits and services to members. As a well-capitalized credit union, members can feel assured their funds are safe and secure at HRCU. We ended 2023 with 24,482 members and \$425M in assets. Despite higher interest rates, loan volume continues to grow but at a slower rate from previous years. Our team worked hard to ensure loan rates remained competitive and often below the industry average.

As a responsible lender, we maintained lower delinquency rates despite the economic uncertainties of the year.

# SUPERVISORY COMMITTEE REPORT

The responsibility of the Supervisory Committee is to ensure the credit union is soundly managed. In 2023, we fulfilled our responsibilities in the following ways:

- An examination was conducted by the State of New Hampshire Banking Department.
- An opinion audit was performed by the GT
  Reilly auditing firm to assess the accuracy
  and integrity of our financials and assure our
  compliance with banking laws and regulations.
- GT Reilly also performed an Allowance for Loan and Lease Losses Audit (ALLL) to determine if HRCU'S calculation of the ALLL is in compliance with its own policies and procedures as well as industry standards.
- TraceSecurity auditing firm performed a comprehensive review of the credit union's Information Technology (IT) operation to assure we had security controls in place.
- The Wipfli auditing firm conducted multiple internal audits.
- New England Automated Clearing House (NEACH) performed an evaluation of HRCU'S compliance with the provisions of the Automated Clearing House rules.

- We received a monthly financial report from our CFO including an end of year fiscal report.
- We reviewed and approved quarterly financial reconcilements.
- We reviewed and approved quarterly branch audits of all branches by management.
- We reviewed and approved monthly visa expenditures by management.
- We reviewed and approved New and Closed accounts on a monthly basis.
- We reviewed and approved travel and conference expenditures by management and volunteers.
- We kept abreast of management's compliance with the recommendations by the auditors.

# HRCU RANKED #1 CREDIT UNION IN NEW HAMPSHIRE

ROCHESTER, NH – HRCU was recently ranked one of "America's Best Credit Unions" by Forbes, a global media company with a focus on news and business. The full-service credit union with \$420M in assets and over 24,000 members ranked first in the state of New Hampshire in 2023. 




